



CEO Report

Dear Friends of Easter Seals Newfoundland and Labrador,


2016 was another successful year for Easter Seals NL. All of our functional units have experienced great success stories and all have advanced our key strategic objectives and initiatives. It has also enabled us to improve our awareness, communication channels, relationships, and create value for our shareholders, particularly our participants, volunteers and donors.

2016 has been an important year of strategizing with all of our functional units. Our Programs Unit has faced its challenges head-on as our new mandate of providing programs to all persons of all disabilities has begun to gain in popularity. Continuous improvement systems such as surveys being conducted after every program allow us to adapt our programs to accommodate all to the best of our capabilities and resources. Registrations are higher than ever and we have hired Melandy Bearns as our administrative receptionist to relieve the registrations and collections tasks from Programs staff.

In March 2016, our Career Services Unit obtained new funding to coordinate the Opportunities Fund for Persons with Disabilities Program, allowing us to support 55 persons with disabilities to secure employment. At the end of 2016 we secured multi-year funding from Service Canada to implement five Horizons Skills Link projects, which will enable us to serve 40 participants who face barriers to employment. Husky Energy, United Way and Canada Post came on as sponsors for our I Can Too Program, allowing us to increase the delivery of our disability awareness presentations and place more focus on outreach. As mentioned we are facing a challenging economic environment and our Fund Development unit has had to reinvent themselves with fundraising events with more of them but they are smaller with many of them created for niche markets such as Cup Cake Battles, Cork and Canvas, and Dodgeball leagues. Our 2016 inaugural luxury cabin lottery was a tremendous success. The 1st annual 2017 luxury cabin lottery promises to be another great success. We launched our See Ability in Disability capital campaign at a time when I would think most would not.

We have been raising monies without wanting nor seeing the justification to spend on a big campaign and yes we have had our struggles in this environment yet Corporate Affairs and Communications have still managed to bring in over \$500,000 and we had our accessible and inclusive Park ground-breaking ceremony today. We will see constructed this 2017 year the playground and BBQ event plaza being built with plans for other Park components for 2018. We are committed to our strategy and targets and promise to deliver excellent results.

This organization and its people have had a tremendous positive impact on me. I am deeply grateful for my position with Easter Seals, and I am convinced the organization is well positioned to continue to prosper and grow. Thank you for your continued support and trust and a particular thank you to the participants of Easter Seals whom we attempt to serve and they pay it back with their beautiful smiles and laughter.

Treasurer's Report

We are pleased to report that the Easter Seals organization is in a very healthy financial position. In 2016, Easter Seals had approximately \$1M in cash, due in large part, to newly launched fundraising initiatives. It is important to note that approximately 950K of this balance is restricted meaning it is not for day-to-day operations. Accounts receivable has increased mainly due to timing. This will fluctuate from year to year. All of our trade payables and long-term liabilities are up-to-date and all assets and amortization has been accounted for. Deferred revenue has increased significantly over the prior year mainly due to monies received for the capital campaign and cottage lottery. As the associated capital projects are completed, these monies will be released into revenue. This will have a positive impact on net income.

Overall revenues have increased mainly due to the success of the cottage lottery and the gala. There was also a slight increase in revenues from some third-party events, government grants and corporate donations. We are striving to build on the success of our events, such as our cottage lottery, to enable our success in the upcoming year.

As consistent with revenue, expenses have increased over the prior year due in large part to some of the events undertaken such as the gala and the cottage lottery. Aside from expenditures related to these two events, expenses have remained relatively consistent with no major variances over the prior year. Amortization of deferred capital contribution is an offset to the amortization of the building.

Although we are subject to normal operating challenges that most charitable organizations are faced with, we are diligently planning and investing for the upcoming years, to ensure a financially prosperous and sound organization to house the programs and services we offer to persons with disabilities in Newfoundland and Labrador.

Career Services

Horizons Employability Skills through Work Experience

Through Funding from Employment and Social Development Canada, twelve youth with disabilities completed a Work Experience Program from May 2, until December 2, 2016. Participants were involved in skills development training as well as work with an employer. Placements included: Wal-Mart Mt. Opportunities Fund Community Coordinator

Through funding provided by Employment and Social Development Canada, on February 26, 2016 we successfully concluded our first delivery as a provincial Community Coordinator for the Opportunities Fund Project. Thirty-seven persons with disabilities entered into a wage subsidy or work experience, exceeding our goal of thirty.

Easter Seals successfully obtained new funding from Employment and Social

Development Canada to continue to deliver the Opportunities Fund Project. Our new project commenced on March 28, 2016. To date we have secured employment for 16 persons with disabilities. (Shoppers Drug Mart), Smallwood Crescent Community Centre Inc. and WFC Property Services.



'I Can Too!' Disability Awareness Program

2016 was a very successful year for the 'I Can Too!' Disability Awareness Program, which saw Easter Seals Newfoundland and Labrador, set the framework for future growth of the program. We were able to deliver over sixty presentations to schools in St. John's, Mount Pearl, Paradise, Conception Bay

South, Portugal Cove-St. Philip's, Coley's Point and Spaniards Bay. We reached over fifteen hundred students with the important message that the 'I Can Too!' Disability Awareness presentation provides. We were awarded two grants for the 'I Can Too!' program from the United Way of Newfoundland and Labrador and the Canada Post Foundation.



Corporate Affairs and Communications

Communications

It has been a busy year for the corporate affairs and communications department. Last year we developed our marketing and communications strategies and this year we began to execute them. We've improved our social media presence, newsletter, and media presence all in the name of telling the wonderful stories that we see everyday at Easter Seals.

Corporate Affairs

We have seen an increase in our corporate engagement rates which has led to both increased awareness of Easter Seals in the corporate community, and increased returns in the form of new and deeper partnerships.

Activities of the corporate affairs department includes boardroom presentations, plaque presentations to existing and prospective partners, food fairs, and The Royal St. John's Regatta.



These activities have led to new and increased funding from both new and existing partners. 
