2018 was a very successful year for Easter Seals NL. Our Programs Team offered over 20 life-changing safe and quality programs to participants of all disabilities and all ages with over 1000 registrations! Thank you to Eileen, Megan, and Jason for the unbelievable time, effort and love you give to the participants.

Our Career Services Team have been entrusted by Service Canada to coordinate and offer the Opportunities Fund and Horizons Program in our province. They have successfully supported a record high of 92 persons with disabilities to secure employment! Thank you to Paula, Rachel, Amy and Chantelle for the unbelievable time, effort and love you give to the participants. Our "I Can Too!" Program increased the delivery of our disability awareness to 106 presentations to 3,487 students in 20 schools throughout the entire province. An amazing achievement by Rachel, Ashley and Eileen.

Our Fund Development and Communications Team consisting of Samantha, Jayme and Ashley have done an amazing job of grant writing, communicating, organizing, planning and putting off over 16 fundraising raising initiatives (many are held multiple times) as listed later in this report. Our 2018 Luxury Cabin lottery sold out!

Our Building and Office Administration Support Team continue to handle so much in the background such as building maintenance, ensuring all inspections and filings are up-to-date and that any remaining building space after programming is rented. Thank you very much to Katie and Melandy for the dedication and effort you put into all this.

We launched our **See Ability in Disability** Capital Park Campaign in 2016. We have been quietly raising monies without seeing the justification to spend on a big campaign. We had our accessible and inclusive Playground Grand Opening in June! In 2019 we begin Phase 2 for the BBQ Event Pavilion and Plaza, Therapeutic Gardens and grass play area for everyone to enjoy.

I'd like to take this opportunity to especially thank those that give the most – their time. Our volunteers are amazing people who are constantly giving to our fund raising events, our building upkeep and our program delivery. We could not offer our programs and services with out them. On behalf of our Board of Directors, Staff, Participants, Families, and the entire disability community, we thank you so much!

Treasurer's Report

We are pleased to report that the Easter Seals organization ("Easter Seals") is in a sound financial position. Cash is in a very stable position year over year and has increased slightly due to success of fundraising activities such as the cabin lottery. Easter Seals is continuing to invest in capital projects to enable the organization to provide programs and ensure continued success for its participants in the future. It is important to note that accounts receivable has increased over the prior year mainly as a result of timing. However, there are no concerns over collectability of the balances. Trade payables and long-term liabilities are up-to-date and all assets and amortization have been properly recorded.

Overall revenues have increased since the prior year mainly as a result of the success of the 2018 cabin lottery fundraiser, as well as, the recognition of 2017 cabin lottery revenues which were deferred in the prior year. Expenses have increased over the prior year mainly as a result of costs related to running of events such as the 2018 cabin lottery as well as expenditures related to the 2017 cabin lottery. As a result of these changes, Easter Seals recognized a net income of \$306,997. It is important to note, that the Board of Directors of Easter Seals has restricted the spending of \$314,000 of these funds as they are to be used for the development of phase two of the park. Therefore they are not for general use within the organization's operations.

Although we are subject to normal operating challenges that most charitable organizations are faced with, we are diligently planning and investing for the upcoming years, to ensure a financially prosperous and sound organization to house the programs and services we offer to persons with disabilities in Newfoundland and Labrador.

- Easter Seals registered 91 new program participants, and 113 new volunteers. in 2018.

- Access Media Inc created a documentary, "Our Community" featuring Easter
 Seals NL Day Camp showcasing our new inclusive and accessible playground.
- Easter Seals NL were guests at Lab West Winter Carnival March 23 –25 giving 3 sledge and 1 boccia demo.
- Easter Seals NL boccia athletes M. Mercer, H. Redmond, Lois Martin and Kristyn Collins travelled to Barcelona, Spain to compete in the CPISRA World Developmental games. Mercer, Martin and Collins won Team Silver, Redmond joined with Team Scotland to win Team bronze. Mike won individual silver and Lois won individual bronze.
- Easter Seals hosted Boccia Day in Canada September 23rd at the Avalon mall, with representatives from Boccia Canada.
- Easter Seals NL hosted the Canadian Boccia Championships in November with athletes from across the country including Newfoundland and Labrador, Quebec, Ontario, Nova Scotia, British Columbia for a total of 34 athlete 11 represented Team NL. 5 Athletes from Team NL made it to the podium.

The Easter Seals NL community also developed many community partnerships that supported persons with disabilities to achieve life changing experiences.

Fund Development

2018 was another successful year in the Fund Development Department. It was the third year of our Ability Classic and our Luxury Cabin Lottery. The Dodge Dive Donate community has fundraised over \$50,000 to date for Easter Seals NL.

Run, Walk, Stroll and Roll was revitalized this year and took place outside in Bowring Park. It was a fun-filled day for Easter Seals participants and family members as we enjoyed a barbecue, music, face painting, games and more after the walk. We owe much of this success to the work of our many committed volunteers and staff members.

Séan McCann returned in December for our gala luncheon "Celebrate the Season with Séan McCann". It was an inspiring event with Séan singing Christmas songs, his own music, and with Easter Seals individuals.

Career Services

Employment and Educational Services



In 2018, a new partnership was developed with the Community Sector Council Newfoundland and Labrador Amplify Program. Through this initiative, two youth with limited work experience gained summer employment working at Easter Seals, Newfoundland and Labrador. Easter Seals staff

members provided coaching, training and direct supervision. Positions included, Support Admin/Fundraising and a Junior Counsellor in Training. This program offered mentored employment and connected youth with peers for creative group and career and personal development opportunities.

Horizons Employability Skills through Work Experience

Nineteen years, and still going strong! With funding from Employment and Social Development Canada Easter Seals, Newfoundland and Labrador continues to coordinate our very successful Horizons Program. In 2018, three of five Horizons intakes were completed and to date we have served a total of thirty-four participants who are facing barriers to employment. From January 16th, 2017 until February 28th, 2020, we will have a total of forty-six youth take part. Participants will be involved in skills development training as well as work with an employer. 'I Can Too!' Disability Awareness Program

In 2018, the 'I Can Too!' Disability Awareness Program saw significant growth and continued to develop to represent the disability landscape within school communities, as well as allow classes to engage with Easter Seals representatives after the presentations. We delivered over ninety presentations to schools in St. John's, Mount Pearl, Paradise, Conception Bay South, Portugal Cove-St. Philip's, Pouch Cove, Logy Bay, Clarenville and Goose Bay. We reached close to three thousand students with the important message that the 'I Can Too!' Disability Awareness presentation provides. Also in 2018, Easter Seals, Newfoundland and Labrador worked with a graphic designer to create a set of characters with disabilities that are left with classes after the presentations are finished. The characters, along with suggested activities, help continue the conversation around disability awareness and allow classrooms to continue

to engage with Easter Seals, Newfoundland and Labrador.

Currently in our fifth year, with multi-year funding from Employment and Social Development Canada, Easter Seals, Newfoundland and Labrador continues to successfully operate as a provincial Community Coordinator for Opportunities Fund for Persons with Disabilities. At the conclusion of our project on September 28th, 2018 we proudly <u>placed ninety persons with</u> disabilities in the workforce.

With a new project underway on October, 1st, 2018 continuing until September 24th, 2021 we will be able to support an additional <u>85 participants in their search for employment</u>. Thus far, eight individuals have secured employment with the following businesses/organizations: Alscott Air Systems, Mad Catter Cafe, Marystown Heritage Museum, NL Housing and Homelessness Network, Posie Row, South Coast Training (Keyin College), St. John's International Women's Festival, and WFC Property Services.
